Title: Unaccompanied Children in Transit: challenges and supporting their rights

Lead organisation(s): Caritas Europa

Objectives:

- Increase understanding of the situation in which unaccompanied minors (UAC) in transit find themselves and the challenges they face along their migratory journey, with examples from the ground and people directly concerned. (e.g. RLO, Xtra MENA project implemented in Brussels which provides support and legal information to UAC in transit in Brussels).
- 2. Discuss actions and strategies put in place in countries along the migratory route (e.g. Belgium, UK, France) to provide diverse services and legal counselling, promote their rights, and facilitate family reunification.
- 3. Discuss the post-Brexit challenges in what concerns family reunification, transiting from Dublin III to the "regular" UK family reunification rules and propose recommendations.

Structure/method: roundtable: panel discussion followed by a Q&A

Description:

In a context of increased crossings' attempts across the Channel and worsening situation for people trying to reach the UK from Belgium and France, the situation of UAC in transit has gained visibility in the last few years. UAC in transit typically are going through extremely



challenging <u>experiences</u> and obstacles along the journey, which is too often marked by abuses and violence.

This panel discussion will bring to light the situation and challenges they face, after having fled from countries like Eritrea, Sudan or Ethiopia- and for many of them transited through Libya and Italy- in a journey that can last for years. Due to the presence of family or diaspora members, perceived better opportunities or lack of accurate information on legal possibilities and rights, the UK often represents for them the Eldorado to reach, regardless of the challenges and violence that the journey entails.

The topic will be illustrated by the <u>Xtra MENA project</u> (see also the <u>report</u>) implemented by Caritas Belgium and partners which provides support and legal information to UAC in transit in Brussels -who often fall in the cracks of the system, ending up in a state of great vulnerability- and advocates for more structural and legal support to UAC, as well as by personal experience from people on the move. Situations elsewhere in Europe, and notably in the north of Italy, will also be examined. Finally, an recommendations for action will derived from the particular case and overview of the situation in Europe.
